5:55 p.m. Public Hearing – Introductory LL #6 of 2025 – The proposed local law amends Chapter 170 - Solid Waste of the NL Town Code to require that refuse containers be placed in a manner that does not obstruct traffic in either direction; and placed out no earlier than noon the day before and removed by noon the day after the designated collection day. Violations are subject to a fine no greater than \$100. The purpose of this change is to facilitate safe and efficient snow removal and other road maintenance activities.
