

Memorandum of Understanding

Between

Town of New Lebanon

and

County of Columbia Youth Bureau

Effective Date: Summer 2024

SWIMS GRANT

(Statewide Investment in More Swimming)

1. PARTIES

County of Columbia Youth Bureau (hereinafter referred to as CCYB, PO Box 458, Hudson, New York 12534); The Columbia County Youth Bureau receives grants from the State of New York for the provision of various youth services throughout Columbia County to be distributed to various providers of such services. The County of Columbia received a SWIMS grant in 2024 to be divided among several county towns, including the Town of New Lebanon.

Town of New Lebanon, having its office and mailing address of 14755 Route 22, Box 328, New Lebanon, New York 12125. The Town of New Lebanon youth program provides summer activities to youth who reside in the town and neighboring towns, including a swimming program.

II. TERM

This MOU is in effect for the summer months of the year 2024.

III. BUDGET

The CCYB and **Town of New Lebanon** will receive an allocation of \$3,571.00 for this SWIMS program. The CCYB shall facilitate payment to the **Town of New Lebanon** program in a timely manner.

IV. REPORTING

At the end of the summer program, the **Town of New Lebanon** shall complete and submit to the CCYB a “*New York State Office of Children and Family Services Program Expenditure Summary (OCFS-3125)*” which specifies all program expenditures.

V: PURPOSE

Funds disbursed pursuant to this grant shall be allocated for the advancement of youth swimming activities. The allocation of these funds is designed to provide summer swimming activities to youth who reside in the town of New Lebanon and neighboring towns.

VI: COOPERATIVE ACTIONS

The County recognizes the **Town of New Lebanon** program is a program offering youth the opportunity to engage in a summer swimming activity.

The **Town of New Lebanon** organization shall have liability insurance covering the activities contemplated under this agreement, and the underwriters shall have no rights of recovery or subrogation against the County of Columbia. Further, the Town (volunteers, etc.) shall hold harmless and indemnify the County and its employees

for any claims or torts arising out of the performance of this agreement.

A copy of the Certificate of Liability Insurance listing the County of Columbia as additional insured is attached hereto.

VII. MISCELLANEOUS

The **Town of New Lebanon** organization agrees to comply with all laws, rules and regulations of any applicable governmental authority. This MOU does not create a partnership, a joint power agreement, or a joint venture and does not create any financial commitments from one party to the other. Neither party has the authority to bind the other to any obligation. It is not intended that this MOU be enforceable as a matter of law in any court or dispute resolution forum. The sole remedy for non-performance under this MOU shall be termination, with no damages or penalty. The County of Columbia and the Town of New Lebanon have executed this MOU as of the date(s) written below:
